## 1 Introduction

The project “MSc Course in Food processing and Innovation-FOODI” is co-funded by the Erasmus+ / Capacity building in higher education programme of the European Union. ## **4 Quality Board Decision-Making**

All members have equal status, acknowledging the importance of the expertise and experience that each member brings to the Quality Board. The person appointed by the WP5 leader, ReadLab, shall chair the Board. The Quality Board will closely cooperate with the FOODI Project Coordinator, Management Board, WP Leaders and external evaluators.

## **5 Quality Board Communication**

Quality Board members will communicate through the FOODI project shared platform. If at least one of its members requests a meeting, this will be promptly arranged by the Quality Board chair and delivered virtually. All members will be notified of the meeting arrangements and agenda one week in advance.
